The cost for a **4-night camp** is **\$210.00 per person**. If your final count is below 350, the minimum payment required is \$73,500.00. Otherwise the final amount due is based on your final count. There will be no discounts for late arrivals or reimbursements for leaving early. The \$210.00 cost breaks down as follows: Lodging \$100, Meals \$66 (11 meals), and \$44 Recreation Activities.

**Price Breaks**

For the 1<sup>st</sup> 500 campers the price remains @ \$200

501-599 pays \$160 (after first 500 remains at \$200) plus Camp WOW provides 1 FREE Late Night party worth \$1500 and 6 FREE lodge rooms.

600+ pays \$150 (after first 599 pay as above) and Camp WOW provides 2 FREE Late Night parties worth \$3000 and 12 FREE lodge rooms.

**DEPOSITS** — A deposit of **\$2,000** must accompany this contract by **Sept. 15<sup>th</sup>**, to reserve your dates. Two additional deposits of **\$2,000** are due on or before **Dec. 1<sup>st</sup>** and **Feb 1<sup>st</sup>**.  
\*\*Make checks payable to Walk on Water, Inc.

A final head count is due 7 days prior to the scheduled event. We consider this count to be guaranteed and your balance will be based on this count. If attendance is below your final count, you will still be required to pay the fees for the final count. The deposits must be paid by a church check. Deposits are deducted from your final balance.

**Cancellation** — It is agreed that if you cancel your camp dates that you will **forfeit** your deposits. Also, you will be held responsible for the payment due of the number of campers per contract, should camp dates be unable to get re-booked in time.

**Insurance** – Upon arrival, the group leader is responsible for providing a Medical Information Form or Release of Liability for each camper. THE CAMP OFFICE WILL NEED RELEASE FORMS AND TOTAL # IN YOUR GROUP AND THE CHURCH CHECK UPON YOUR ARRIVAL.

**KEYS** – Please leave room keys in lodge rooms when you leave! There will be a \$5 charge for lost or misplaced lodge keys.

**Church organization must provide tax exemption letter with contract and deposit.**

**Nurse** – The group agrees to bring their own nurse and supplies to attend to their campers as needed. We do have a nurse's station available for him/her to work out of and stay in. Camp Walk on Water does NOT provide a camp nurse.

**DAMAGES** – Please note: Before leaving campgrounds, camp staff will inspect facilities, and any damages will be charged to church. Please leave campgrounds and facilities clean. Thank you.
